

RESPECT TO TAKE A STAND!

Unique in the southeast, the Florida Constitution guarantees the right of public school educators to collectively bargain your contract, covering your salary, benefits, and work conditions.

Under state law, this can ONLY be done through your union-WITHOUT PESPA, YOUR CONTRACT WILL IMMEDIATELY END.

In 2023, state lawmakers removed your right to pay your union dues through payroll deduction and raised the membership threshold to 60%. Now, the state has added to their previous position, requiring all members to complete a 3-page long member form, or they won't be counted toward the 60%.

These attacks have made it impossible for PESPA to reach our 60% duespaying membership by August 2024, and without this, we cannot remain certified as your union.

PESPA must now gather "Showing of Interest" cards for over 30% of all unit employees (members and non) to go to a certification election in Fall 2024. These Salmon colored showing of interest cards do not constitute membership, and they cost no dues- they are a petition to state you wish to keep your contract, negotiated by PESPA.

If PESPA fails to gather enough cards or loses the election, you will lose your existing contract- even a brand new union would have to start from scratch. Your salary, health insurance, work environment, & RESPECT-all of these rights will be out of your hands.



If you want to keep your rights, you must complete and return both Showing of Interest cards today and Vote for PESPA in the Fall 2024 Election.

Interest Card Campaign

The only guarantee to maintaining your contract is to meet the 60% membership requirement for renewing your registration.

BACKGROUND:

Each year our union must renew its registration with the Public Employees Relations Commission (PERC) to remain the bargaining agent and therefore maintain the contract. A new law now requires that our union must have at least 60% membership 30 days before our registration renewal which is ______. Without a certification from PERC, our guaranteed seat at the table and our contract goes away. Therefore it is important that we continue to grow membership and maintain a minimum of 60% of the bargaining unit as dues-paying members to guarantee that our contract remains.

If our union doesn't meet the 60% membership requirement when renewing the registration, we are able to petition for an election thru PERC that requires that we submit signed "showing of interest" cards from employees. Upon determination that the petition is sufficient, PERC will schedule an election in which all bargaining unit employees will have an opportunity to vote on who will represent them or if they do not want any representation. If our union is successful with this vote, our contract will remain. If not, the contract goes away.

INTEREST CARDS:

In order to file a representation petition with PERC, it requires a valid showing of interest which is achieved by collecting Interest Cards.

Card Requirements:

- The card must expressly authorize the petitioning employee organization to represent such employees for the purpose of collective bargaining.
- We recommend 40-50% to account for any cards in case some are challenged or thrown out.
- The card requires a "wet signature" so it must be signed and dated in ink. Electronic signatures are not accepted.
- Any member of the bargaining unit is eligible to sign a card.

NOTE: An interest card campaign does not guarantee that your contract is secure as challenges and election outcomes can impact this process.
